Respective responsibilities

Medtronic is responsible for preparing the data and for its correct presentation in the Questionnaire, including disclosure of the reporting criteria and boundary.

ERM CVS' responsibility is to provide conclusions on the agreed scope based on the assurance activities performed and exercising our professional judgement.

Our conclusion

Based on our activities, nothing has come to our attention to indicate that the corporate FY22 data for the selected water data as shown below and reported in section W1.2h of Medtronic's Questionnaire are not fairly presented, in all material respects, with the reporting criteria.

Total purchased water withdrawal (third party sources): 1,760,000 cubic meters

Our assurance activities

A multi-disciplinary team of sustainability and assurance specialists performed a range of assurance procedures. Which varied across the disclosures covered by our assurance engagement, as follows:

- Interviews with relevant staff to understand and evaluate the data management systems and processes (including IT systems and internal review processes) used for collecting and reporting the selected data;
- Virtual visits to six Medtronic locations (Boulder, USA: MECC, USA; Mirandola, Italy; Tempe, USA; Tijuana Nellcore, Mexico; Northridge, USA) to review local reporting processes and consistency of reported annual data with selected underlying source data:
- An analytical review of the data from all sites and a check on the completeness and accuracy of the corporate data consolidation;
- A desk-based review of invoices for the above selected sites to review accuracy of reported activity data;
- A walkthrough of Medtronic's incorporated environmental data management system, including the internal controls, unit conversions used in the system;
- Examination of the presentation of information relevant to the scope of our work in Medtronic's Questionnaire to ensure
 consistency with our findings.

The limitations of our engagement

The reliability of the assured data is subject to inherent uncertainties, given the available methods for determining, calculating, or estimating the underlying information. It is important to understand our assurance conclusion in this context.

Force Majeure - COVID-19

Due to travel and distancing restrictions imposed following the outbreak of COVID-19, we were unable to undertake our standard assurance activities that would include in person visits to both Medtronic's head office and operational sites. While we believe these changes do not affect our limited assurance conclusion above, we draw attention to the possibility that if we had undertaken in person visits, we may have identified errors and omissions in the assured information that we did not discover through the alternative assurance program.
