

A clear understanding of emissions footprints is the foundation for setting meaningful decarbonization



What we expect from suppliers

- Calculate or estimate GHG emissions annually.
- Use credible methods for data accuracy and consistency.
- Set credible, science-based targets.
- Share data transparently through established reporting process. (CDP or Watershed).

Actions for suppliers to take

- Use external tools and resources to calculate emissions.
- Identify major sources of emissions and collect available data.
- Leverage recognized frameworks to ensure credibility and consistency with market expectations.
- Establish decarbonization targets that align with climate science and reflect organizational capacity to act.
